#### 4.1. Description of first aid measures

#### **General information**

# 4.2. Most important symptoms and effects, both acute and delayed

Sensitivity effects: This product contains substances which can give an allergic reaction on contact with skin. The allergic reaction will typically set in 12-72 hours after exposure as the substance penetrates the skin and reacts with proteins in the outer skin. The body's immune system sees the chemically changed protein as a foreign body and will try to destroy it.Irritation effects: This product contains substances which cause irritation to skin and eyes, or when inhaled. Contact with locally irritative substances can cause the area of contact to be more prone to absorb damaging substances such as allergens.
